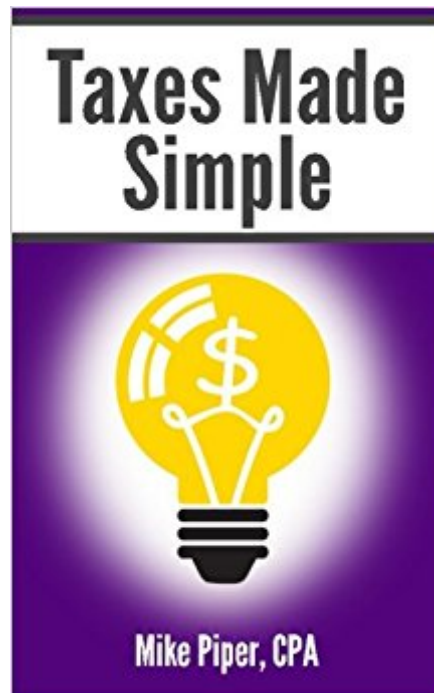

I learned a lot from this book and highly recommend it for anyone who's puzzled by taxes. It's an easy read that put everything in very simple terms, which I needed. I had never heard of 'above the line' and 'below the line' deductions, which are important to know. After reading this book you'll be better prepared for either doing your own taxes or quizzing your accountant about what he/she is doing. I wish I'd read this years ago.

A great introduction to taxes. Quick and easy read. Found it most helpful to read with pad of paper, pencil and calculator to test self with various scenarios from each chapter. Can use it in these ways:  
1. Quick intro to concepts in taxation. Made it easy to decide if you get it or not and even if you like it or not. Probably would be smart to read it before deciding if you want to do your own taxes.  
2. Resource for clients' questions. Most of the chapters align with client questions. Piper's book can

remind you of the short answer and gives simple examples that are easy to share.<sup>3</sup> Training for new staff. This book is perfect for new employee (ex: receptionist, data entry, customer care, intern). It helps them quickly grasp a basic understanding of taxation. Often they feel better also - some of the mystery and fear of taxation disappears - an esteem-builder.

All of Mike's books are great. He's a master at simplification! Like other reviewers, I wish I had read this years ago. It would be a perfect thing for parents to use for educating their children on what to expect when they enter adulthood and encounter their first W-2, and for college or early career people who are starting to accumulate tax deductible life events. The new online tax programs make it much easier to catch things before filing, but this book is a great companion. Even at 50+ years of age, I learned new things and it's helped me make better choices for the rest of my tax-filing years. When it comes to taxes, it's never too late! Thank you Mike!
