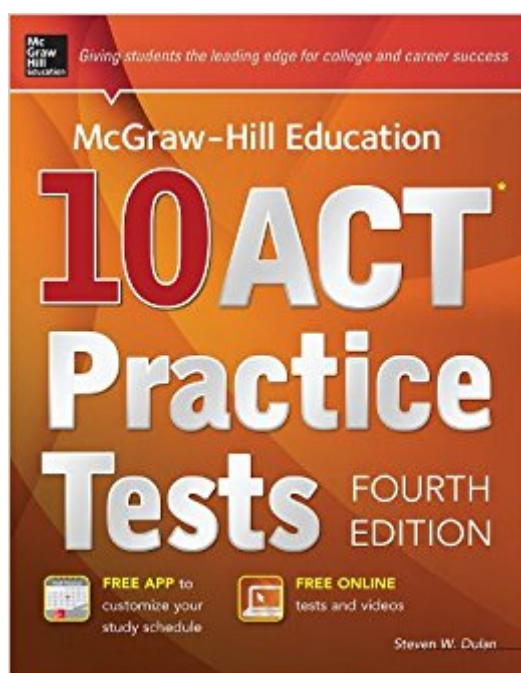

This book contains significant errors. Specifically - test 6 and 7 both have a ratio problem that is incorrectly explained and the answer is wrong. Test 2 has an error in one of the science passages (but the explanation is correct - its just wrong on the multiple choice). So USE THIS BOOK WITH

EXTREME CAUTION! While it does contain a good general review, it is not hard enough to raise a child's score past a 26 or 27. I am speaking from over 20 years as an ACT tutor. Go back to the best - go to Barrons! it works better

I was disappointed to find that the fourth edition had not improved from the third.

There is no difference between the previous edition and the new one. I already had the previous edition. I thought that the new edition would have new papers, but that was not the case.

Instead of a scoring chart for each test, there is a single generic formula ($\text{right}/\text{total} * 36$) and then a correction factor (+ or - a point or two, depending on the subsection). It seems likely more valid for scores closer to the mean & not so great for the outliers.

As an ACT Tutor it is difficult to find quality publications that offer a decent amount of testing materials. My students like the fact that they get 10 full length practice exams out of this book. I find the questions on par with the real college board prepared materials. We generally start with the college board book (red edition) and then "graduate" to this workbook.

My ACT score went up!

This is not new material. They just slapped on a new cover; it has no new material in it and is not keeping up with the subtle changes being made to the ACT.
