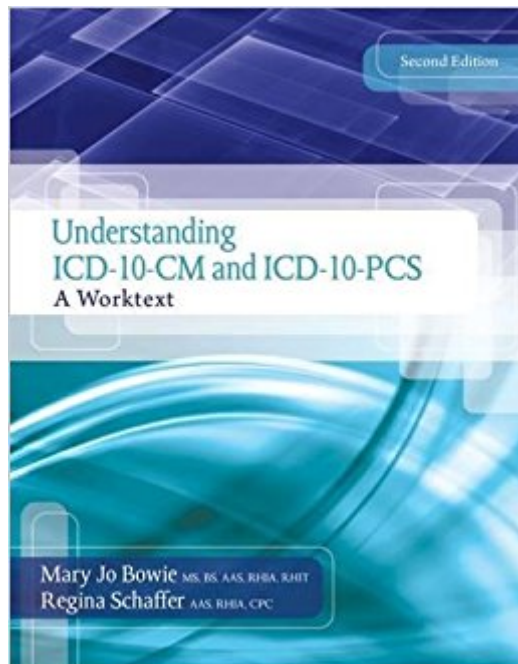

I took a class earlier on ICD-9-CM and really wish this textbook had been used and/or available at that time. Keep up the good work!

My wife is a medical coder. She wants to study for CIC certification (PCS coding), and the available choices seem to be pretty limited. I got her this hoping it would help, as it says "PCS" in the title. Well, it turns out only the last five chapters cover PCS (out of 32), and the book has no answers for the problems, not even the odd ones, which makes it next to useless for self-study. I guess it's not a bad book if you have a teacher with the answer guide, but she doesn't. You might be able to find instruction videos which use this book, but expect to pay quite a bit.

An excellent primer for learning ICD-10! At the end of each chapter are questions covering the material with answers in the back. I used this book and aced my ICD-10 update requirement (AAPC).

Gives good training of what to expect in coding simple cases when ICD-10 comes next month. I would have given it five stars but there is no answer key to check your answers; unless there is something I missed.
